5	<b>Admissions Criteria</b> <i>Description of admission factors</i> All applications (MEN, MS and PhD) received in MSEN are reviewed under the same process. We have rolling admissions. Applications are compiled and sorted into batches dependent on when all application material and supporting documents have been received. In each batch, domestic and international applicants are compiled in different tabs in a spreadsheet for review by Graduate Program Director and Admissions Committee.
	The Graduate Program Director completes a pre-screening of the candidates. The top students with GRE scores of 155+ and 165+, 3.5+ GPA, and recommendation letters (ranking mostly in top 1%) are sent to review by one member of MSEN admissions committee, and upon his/her approval accepted in program. Students with GPA below 3.5, GRE V below 146 and/or recommendation letters with most of the rankings in 25% or below are also reviewed by one member of MSEN admissions committee, and upon his/her approval denied. All other applicants (in-between the mentioned criteria) are reviewed by a minimum of two MSEN admissions committee members and Graduate Program Director. Additional criteria for their acceptances are as follows: rankings of their previous undergraduate and graduate programs; evidence of research experience; publications. MSEN admission committee comprises of 8 faculty (full, joint, and affiliated) members.
