	<p>The basic requirement for admission to graduate studies at Texas A&amp;M University is a scholastic record which, over at least the last two years of full-time academic study in a degree program, gives evidence of the applicant's ability to do successful graduate-level work. Specific requirements for admission into the Nutrition and Food Science graduate program include a minimum grade point average of 3.0 (on a 4.0 scale) on the most recently earned degree , competitive with a score of at least 300 (combined Verbal and Quantitative scores) on the Graduate Record Examination (GRE), and three letters of recommendation.</p> <p>For International Students whose native language is not English, the Test of English as a Foreign Language (TOEFL) is also required, with a minimum score of 550 (Paper based), 213 (Computer based) , 80 (Internet based).</p>
